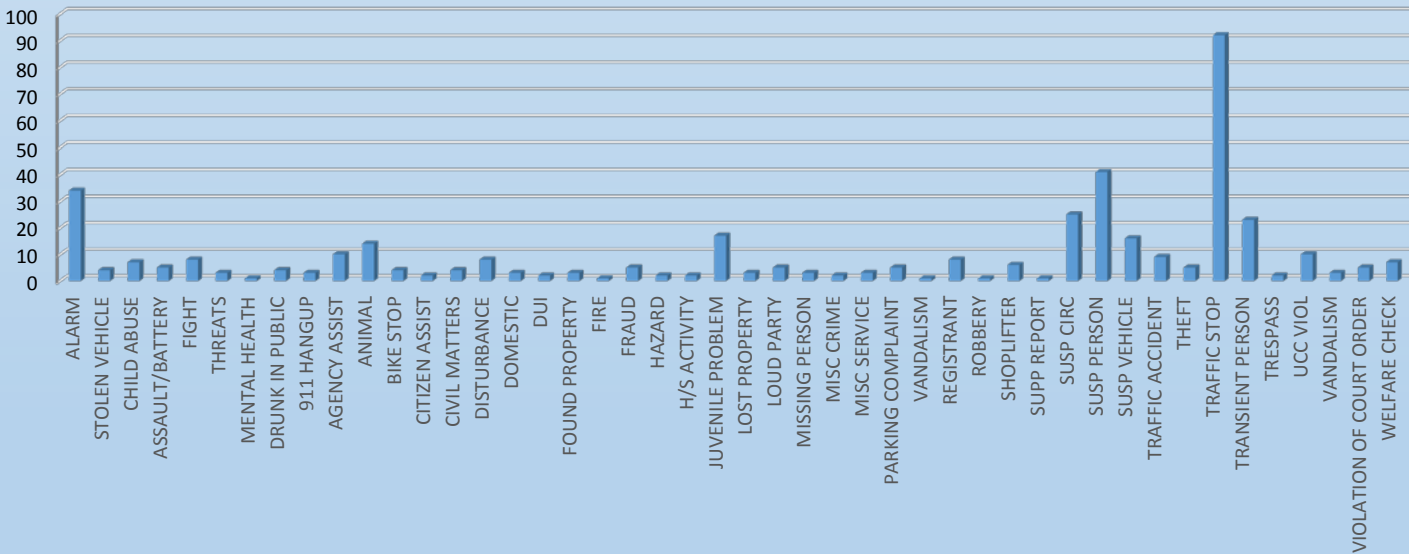

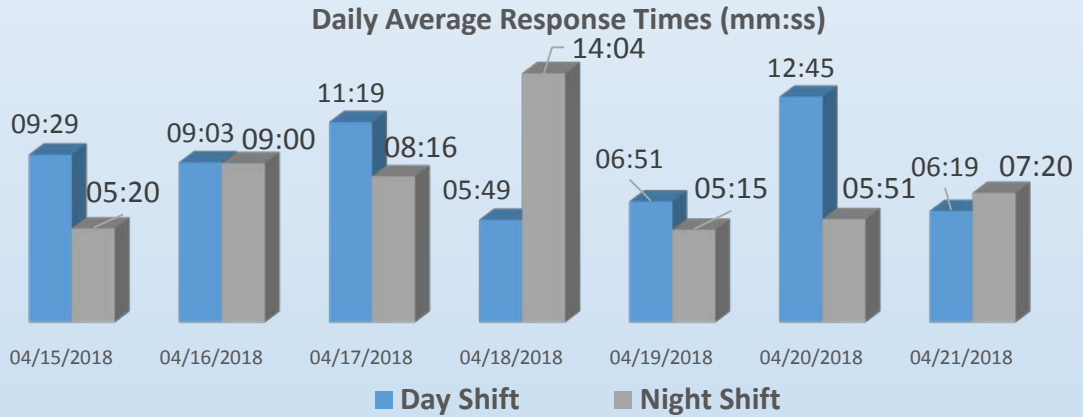

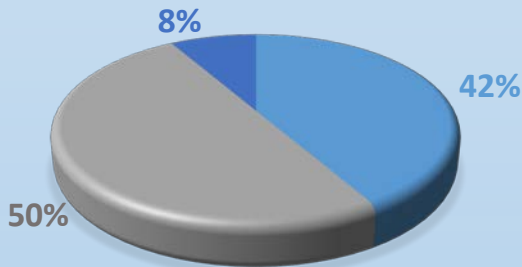

The Patrol Division's response time to in-progress calls was just over 2 minutes.

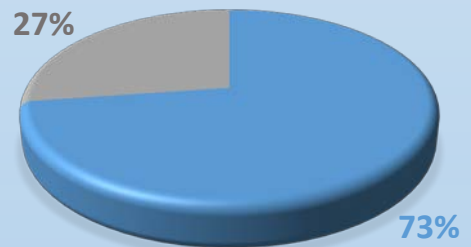
The average response time to all calls was just over 8 minutes.

CRIME BREAKDOWN



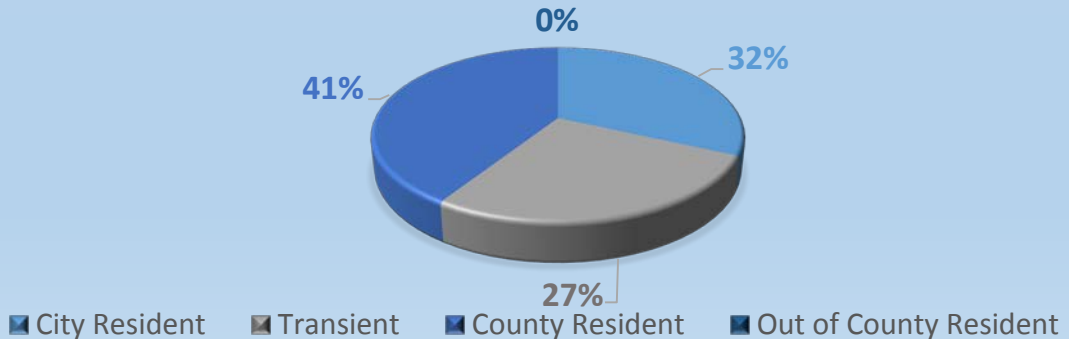
■ Felony ■ Misdemeanor ■ DUI

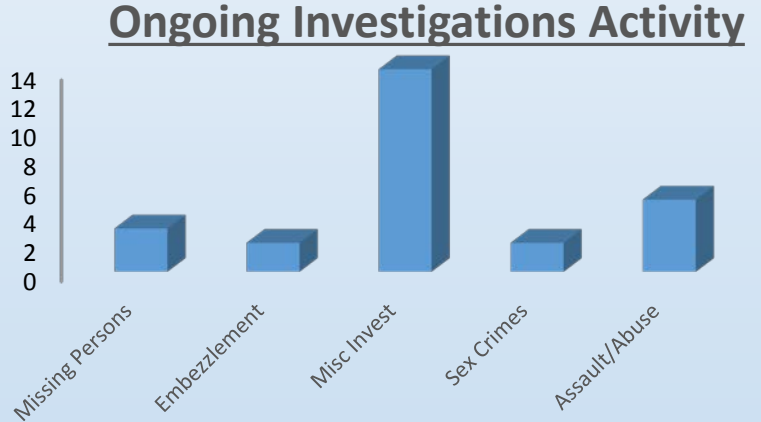

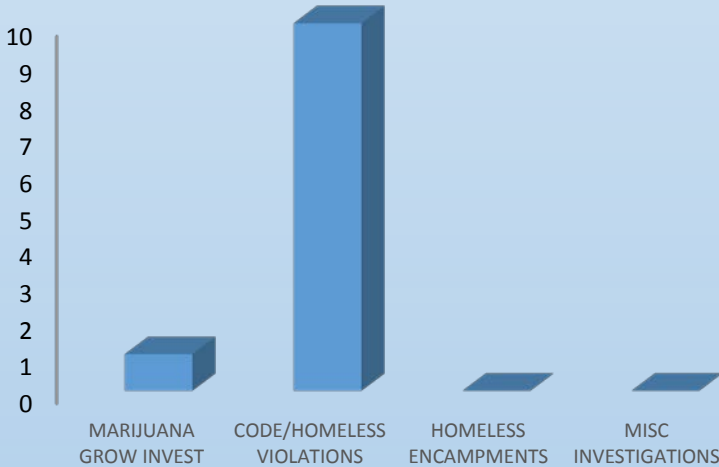

Performance Review 2018

It is important for organizations to evaluate their performance regularly. It helps them understand what they've accomplished, where they stand compared to previous years and current goals, and most importantly, what to focus on in the coming year.

Here at the Ukiah Police Department (UPD), we've developed a long-term strategic plan called *Measuring What Matters Most*. It clearly defines goals for the effective delivery of police services so we can continue to improve safety and quality of life in Ukiah.

As you can imagine, keeping Ukiah safe can be challenging. Our officers work hard to reduce violent crimes and property crimes—and they do a great job. But that doesn't stop them from looking for ways to do even better. That's why our long-term strategic plan is so important.

Our long-term goals are:

- Reducing Crime and the Fear of Crime
- Improving the Quality of Life in Our Neighborhoods
- Enhancing Community and Police Partnerships
- Developing Personnel
- Continued Accountability

I am happy to report that last year our community saw a significant decrease in crime. Overall, crime decreased by 15 percent from the previous year, continuing a trend that has included a 25 percent decrease in crime during the last five years. That's a significant achievement, as there is no more important goal than reducing the impacts of crime in our community.

We divide crimes into two main categories: violent crimes, which include homicide, rape, robbery and assault; and property crimes, which include burglary, theft, vehicle theft, and arson. Violent crimes are down by 9 percent from last year, and property crimes are down by 20 percent.

One of the ways we decrease crime is to solve crimes as quickly as we can after they are reported—this prevents criminals from committing additional crimes. Last year, our officers solved 77 percent of the reported violent crimes in our community, compared to the statewide average of 45 percent. We also solved 53 percent of the reported property crimes, compared to the state average of 12 percent. I'm really proud of our officers.

The second goal of our strategic plan is to improve the quality of life within our neighborhoods, and we recognize that the transient population is causing significant problems in this area.

We know we can't arrest our way out of homelessness, so we're looking for alternative paths for people who desire assistance. To this end, UPD is collaborating with community partners to find long-term solutions. By collaborating with multiple agencies, homeless people who want to become self-sufficient can get the assistance they need, and we can reserve law enforcement resources for people who choose a transient lifestyle and continue to harm our community.

Although violent crime in Ukiah is decreasing, our community still has too many violent crimes. Part of the reason is that more criminally sophisticated people have been relocated to our community. In an effort to save money, the state implemented a program called Realignment, which relocates state inmates to county jails and those on probation to local communities like ours. As you'd expect, statistics show that many of these people are likely to re-offend in the future.

To address these and other complex issues, we at UPD review our progress annually, taking a close look at what's working and what isn't. We then develop a plan to address local crime trends for the upcoming year. One of the most important parts of this process is working collaboratively with you, our community members, to make Ukiah safe.

Tonight, April 18, at 6:00 PM we will present our latest performance report to the Ukiah City Council, and we invite you to attend. We will share our work in the five goal areas, reviewing last year's progress and presenting our plan for keeping Ukiah safe in the coming year. Subject Who Arms Himself with Pipe, Threatens Officers and Crawls Under a Business Taken Into Custody UPD Case 18-0981

On April 17th at about 2:11 pm, a UPD officer was dispatched to the northeast corner of the Umpqua Bank parking lot, regarding transients loitering near parked vehicles and littering in the parking lot. The officer located and contacted the group in the parking lot. While talking to the transients, the officer heard a male subject screaming nearby and was flagged down by a female subject. The female, worked at a nearby business on E. Mill Street, The Office Bar. She advised that the male that was yelling, was located underneath the business, in the crawl space of the foundation. The subject was unknown to employees at the bar and he was unwanted at the location.

The officer contacted the male subject at the crawl space opening. The male was lying on the ground, with only his head, an arm and shoulders protruding. The officer recognized the subject as Timmy Cooper age 56, from Ukiah, who had been arrested early this year for assault with a deadly weapon. Cooper was immediately hostile and uncooperative toward law enforcement, while threatening officers and arming himself with a pipe. A records check revealed that Cooper was on probation.

Officers attempted to negotiate with Cooper, who became increasingly more agitated and threatening. Three officers had to crawl under the building, deploy pepper spray and the use of a Taser to take Cooper into custody. Cooper was booked into county jail for felony threats and resisting, violation of probation, along with committing a felony while out on release from jail.

A Call Regarding Man Asleep Behind the Wheel of Vehicle Leads Officers to Drug and Firearms Arrest UPD Case 18-0974

On April 17th at about 3:20 am, UPD officers were dispatched to the intersection of Cochran and Helen Avenue, to investigate a report of a male subject asleep at the wheel. The vehicle was reported to be stopped in the middle of the roadway. Officers arrived on scene and located a black colored Chevy Impala. The vehicle was running and the driver asleep. An officer woke the driver and could smell the odor of marijuana coming from inside the vehicle. While speaking with the driver, the officer suspected he was under the influence of drugs. The driver was identified as Joseph Angenete age 42, out of Willits. During the subsequent investigation, a loaded semi auto handgun was found, along with suspected methamphetamine, a meth pipe and marijuana. Angenete was placed under arrest for possession of meth for sale, transportation of meth, armed in the commission of a felony, armed prohibited person, possession of a controlled substance while armed and possession of a meth pipe. A record's check revealed that the firearm had been reported stolen out of Georgia. Angenete was booked into county jail for the listed charges.

A Report of a Stolen Car Leads to Arrest UPD case # 18-0994

On April 19th at about 6:26 am, a UPD officer was dispatched to the Ukiah Hampton Inn, on Airport Park Blvd., regarding a stolen vehicle report. Upon arrival, the officer spoke with the owner of the vehicle. The owner reported that the night prior on the 18th, he parked his black 2010 Toyota Prius, in the parking lot of the hotel. The owner stayed the night and the next morning noticed his vehicle missing, just prior to calling the police. At about 8:54 am, an alert UPD officer spotted the stolen vehicle traveling in 600 block of South Main Street. A high- risk enforcement stop was conducted on the stolen vehicle in the 300 block of South School Street, involving several UPD units and closing the street for about 10 minutes. The driver and passenger were safely taken into custody. The driver was identified as Sergio Espinoza age 23 and passenger as Danielle Daugherty age 26, both transients. A records check revealed that both were on probation. Espinoza and Daugherty were placed under arrest for vehicle theft and for violation of their probation. Both were booked into county jail.
